MICRO PENSIONS

The Micro Pensions plan was officially inaugurated by President Muhammadu Buhari on the 28th of March, 2019. During the course of the workshop, Over 100 groups of artisans, farmers and traders have been sensitized across the zone as held between April – May 2019, over 1000 customers have been registered and assigned PINS within this period.

SUBMISSION OF NOMINAL ROLL: NOTICE TO ALL FGN TREASURY- FUNDED MINISTRIES, DEPARTMENTS AND AGENCIES (pg. 37 Daily Trust, 17th July, 2019)

The National Pension Commission (PenCom) hereby reminds all Treasury-Funded Ministries, Departments and Agencies (MDAs) to submit their updated nominal roll twice a year (i.e January and July), to the commission.

The nominal roll facilitates accurate determination of monthly contributions of each employee before remittance is made into individual Retirement Savings Accounts (RSAs).

Please note that failure to submit the nominal roll would affect the prompt remittances of pension contributions to their respective employees' RSAs.
